APPROVING MAP OF CARMEL DEL MAR NEIGHBORHOOD
5 EAST UNIT NO. 12.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Lawrence E. Cole, Licensed Land Surveyor, entitled "CARMEL DEL MAR NEIGHBORHOOD 5 EAST UNIT NO. 12, being a subdivision of a portion of the southwest quarter of Section 20 in Township 14 South, Range 3 West, San Bernardino Meridian, and portions of Parcels 23, 29, and 30, of Parcel Map No. 12871, in the City of San Diego, County of San Diego, State of California, according to official plat thereof, together with a portion of Carmel Valley Road as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of the City is hereby authorized and directed to endorse upon the map, as and for the act of the Council, that the Council has approved the subdivision

map; and the easement with the right of ingress and egress for the construction and maintenance of sewer and water facilities, as granted and shown on the map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
