APPROVING PARCEL MAP W.O. NO. 119986.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Ronald C. Parker, Licensed Land Surveyor, entitled "PARCEL MAP W.O. NO. 119986, being a division of Lot 2 of Eastgate Technology Park Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 10830, filed in the office of the County Recorder of San Diego County, January 30, 1984," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map is in substantial conformance with the approved tentative map; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Towne Centre Drive, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the parcel map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of the City is hereby authorized and directed to endorse upon the parcel map, as and for the act of the Council, that the Council has approved the parcel map and that the portion of a street is accepted on behalf

of the public and The City of San Diego, a municipal corporation,  
as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of the City is hereby  
directed to transmit the parcel map to the County Recorder of the  
County of San Diego, California.
