APPROVING PARCEL MAP W.O. NO. 910617.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Tat L. Wai, Registered Civil Engineer, entitled "PARCEL MAP W.O. NO. 910617, being a division of a portion of Pueblo Lot 242 of the Pueblo lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof, made by James Pascoe in May, 1870, filed as Miscellaneous Map No. 36 in the office of the County Recorder of San Diego County, together with a portion of Sports Arena Boulevard (formerly Frontier Street) as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that the parcel map is in substantial conformance with the approved tentative map; that the parcel map and the division of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Council hereby presently rejects as a dedication those portions of Parcels 1 and 2, marked "Reserved for Future Streets," as shown on the parcel map, under the provisions of Government Code section 66440, but reserves the right to dedicate all or any portion of such reserved area to public street purposes at any time in the future.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon the parcel map, as
