RESOLUTION NUMBER R-280893

ADOPTED ON OCT 19 1992

WHEREAS, the California Department of Boating and Waterways (DBW) offers four forty-hour modules of training in the area of Boating Rescue and Enforcement, which are approved by the Port Captains and Harbor Masters Association and the California Boating Safety Officers Association; and

WHEREAS, DBW has requested that the City of San Diego host two classes, SEAMANSHIP AND RESCUE BOAT HANDLING and MARINE FIREFIGHTING; and

WHEREAS, the classes will be open to agencies involved in boating safety, rescue, and enforcement, including lifeguards, harbor patrol officers, and law enforcement officers; and


WHEREAS, by hosting these classes, San Diego staff members will be able to attend such classes without incurring travel costs; and

WHEREAS, DBW will reimburse the City of San Diego for the cost of the classes up to \$10,965.00 and a Certification of Appropriation in the amount of \$10,965.00 has been received from DBW; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to permit the Park and Recreation Department, Lifeguard Services Division, to conduct two classes: SEAMANSHIP AND RESCUE BOAT HANDLING and

MARINE FIREFIGHTING, to be co-sponsored by the State of California, Department of Boating and Waterways.
