

RESOLUTION NUMBER R-280902

ADOPTED ON OCTOBER 19, 1992

WHEREAS, on June 24, 1992, the Public Facilities and Recreation Committee considered the Park and Recreation Department's proposed new fees for Fiscal Year 1993; and

WHEREAS, the Public Facilities and Recreation Committee approved two of the four proposed fees and forwarded the other two proposed fees, Senior Monthly Tickets, and Non-Resident Fees at Balboa Park Golf Course, to the City Council without a recommendation; and

WHEREAS, on October 19, 1992, the City Council heard the proposed fee schedule and added certain language to be included in a revised resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Senior Monthly Ticket rate of thirty-eight dollars (\$38.00) at the Torrey Pines and Balboa Park Golf Courses be maintained;

2. The manholes at Switzer Canyon be sealed before the rainy season to alleviate possible overflow problems at the Balboa Park Golf Course; the item be returned to the Public Facilities and Recreation Committee in Spring 1993 with a report on the success of this action; if problems remain, then re-evaluate the problem and consider moving the storm drain CIP to Fiscal Year 1995 from 1997 as currently scheduled;


3. Trees be added to the Balboa Park Golf Course CIP to further beautify the golf course;

4. Park and Recreation Department is to devise a policy giving first priority at these golf courses to the residents and resident golfers to alleviate the fear that the City is creating golf courses for tourists, and return to Council with this policy and the fee schedule for non-resident golf fees at Balboa Park; and

5. Maintenance of the golf courses be a number one priority to ensure that the City does not lose revenue.
