- 2. That the provider is required to make a resolute effort to recruit and hire all the incumbent field supervisors serving The City of San Diego as of June 30, 1993.
- 3. That the City Manager be and he is hereby directed to take any necessary steps in dealing with the Civil Service Commission on the issue of working out a process that would allow the Fire Department to bid on the contract and to work with the City Attorney in reviewing a possible conflict of interest to the

City in the bidding procedure.

4. That the bidders' conference is changed from November 18, 1992 to November 13, 1992 with Council review at the meeting of November 17, 1992.
