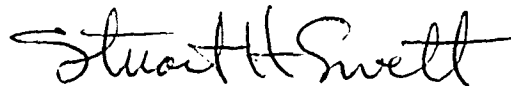
BE IT RESOLVED, by the council of The City of San Diego that the low base bid of NIELSEN CONSTRUCTION COMPANY, a California corporation, meeting the specifications for POINT LOMA WASTEWATER TREATMENT PLANT SOUTH EFFLUENT OUTFALL CONNECTION in the City of San Diego, California, is hereby accepted.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$11,499,000.00 is hereby authorized solely and exclusively for said project and related costs.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer \$2,590,000.00 from Sewer Revenue Fund 41506, CIP 44-001, ANNUAL ALLOCATION - SEWER MAIN REPLACEMENT PROGRAM, to CIP 46-134.0, POINT LOMA SEDIMENTATION BASINS 11 AND 12.

BE IT FURTHER RESOLVED, that the additional expenditure of \$2,590,000.00 from Sewer Revenue Fund 41506, CIP 46-134.0, POINT LOMA SEDIMENTATION BASINS 11 AND 12 AND EFFLUENT CHANNEL MODIFICATIONS, to supplement the funding authorized by Resolution No. R-280005, adopted on May 26, 1992, is hereby authorized for the purpose of executing these contracts.
