BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$450,000 from CIP 52-436.0, "National Avenue from SR-15 to 43rd Street," Proposition 'A' one-half percent sales tax, Fund 30300, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
