
ADOPTED ON OCT 26 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a pipe line license agreement with the Atchison, Topeka & Santa Fe Railway Company, for crossing their right-of-way with the City's Rose Canyon Trunk Sewer pipeline and temporary right-of-way entry along a portion of their right-of-way during construction of said sewer pipeline, under the terms and conditions set forth in the Pipe Line License on file in the office of the City Clerk as Document No. RR-280942, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,500 from Sewer Revenue Fund 41506, CIP 46-111.0, Rose Canyon Trunk Sewer, is hereby authorized, solely and exclusively for the purpose of providing funds to execute said agreement.
