BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to the agreement with the Linda Vista Community Development Corporation, for neighborhood development activities, the original being on file in the office of the City Clerk as Document No. RR- 280948, with the exception that the term of the agreement shall be for the period November 1, 1992 through November 30, 1992, and the amount of the agreement for that period shall not exceed \$6,900.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$6,900 from Fund 18528, Dept. 4030, Org. 3003, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Attorney shall be directed to prepare an addendum to the agreement to reflect its length and dollar amount.
