WHEREAS, while working on his M.A., Mr. Stringer initiated the first intern program at the Medical Center for students in the health sciences and served as the Center's first intern; and

WHEREAS, Mr. Stringer has held a series of positions at the Medical Center since his first as a cashier and was eventually named Associate Director of the UCSD Medical Center in 1976 and Senior Associate Director in 1983; and

WHEREAS, Mr. Stringer has been Director of Hospitals and Clinics and Associate Vice Chancellor of Health Sciences at the UCSD Medical Center since 1984; and

WHEREAS, Mr. Stringer is responsible for all functions of UCSD Medical Center and its affiliated patient care sites; and

WHEREAS, under his leadership, the UCSD Medical Center has evolved as a regional medical center providing highly specialized and critical care services, as well as a wide range of primary care programs; and

WHEREAS, Mr. Stringer is managing the development of an

expanded UCSD health care network to meet the changing needs of the community and enable the UCSD Medical Center to continue fulfilling its mission of teaching, research and patient care; and

WHEREAS, Mr. Stringer's life is a San Diego "rags to riches" success story, and an inspiration to us all; and

WHEREAS, Mr. Stringer is being honored October 30th by UCSD for his 25 years of exemplary service to the UCSD Medical Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, joins the University of California San Diego in honoring Michael R. Stringer and does hereby proclaim October 30, 1992 as Michael R. Stringer Day in The City of San Diego.
