ADOPTED ON OCT 27 1992

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of I TRE CORPORATION is hereby accepted and the City Manager is hereby authorized to execute a primary contract for furnishing HAULING SERVICE FOR TREATING OR REMOVING AND DISPOSING OF WET SCUM as may be required for a period of one (1) year beginning September 1, 1992 through August 31, 1993, at a cost of \$0.375 per gallon, for a total estimated annual cost of \$97,500.00; terms 1% 10 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 6%.

BE IT FURTHER RESOLVED, that the second low bid of ARBORTECH INC. is hereby accepted and the City Manager is hereby authorized to execute a secondary contract for furnishing HAULING SERVICE FOR TREATING OR REMOVING AND DISPOSING OF WET SCUM as may be required for a period of one (1) year beginning September 1, 1992 through August 31, 1993, at a cost of \$64.78 per treated ton for a total estimated cost of \$84,214.00, plus the City's cost of approximately \$20,000.00 to haul the material to Fiesta Island for treatment, for a grand total of \$104,214.00; terms net 20 days, with options to renew for four (4) additional one (1) year


