A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A REPRESENTATIVE PROJECT
AREA COMMITTEE FOR THE CENTRE CITY
REDEVELOPMENT PROJECT AREA.

WHEREAS, the Council of the city of San Diego (the
"Council") by Resolution No. R-276511, adopted the Procedure for
Formation of the Project Area Committee (PAC) for the Centre City
Redevelopment Project at its September 11, 1990 meeting; and

WHEREAS, an election was held in the community in which the
Centre City Redevelopment Project is located on October 19, 1992,
to elect the members who are to serve on the Project Area
Committee; and

WHEREAS, an election was conducted after notice and
according to established procedures enumerated within the
documents approved by the City Council and a representative from
the City Clerk's office attended the election to ensure its
validity; and

WHEREAS, the elected members of the Project Area Committee
have submitted to this City Council information establishing the
qualifications of each person relative to district, category, or
organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as
follows:


1. That the Centre City Redevelopment Project Area
Committee consisting of the persons named on the list of Project
Area Committee members receiving the highest number of votes

attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.

2. That the Council hereby concurs that the election results are valid and binding in accordance with the procedures so adopted by Resolution No. R-276511.

3. That the Redevelopment Agency of The City of San Diego is hereby directed to continue consulting with and obtaining the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area for a period of three (3) years after the adoption of the Centre City Redevelopment Plan, which was adopted May 11, 1992 by Ordinance No. O-17767.
