 Area Committee members receiving the highest number of votes

attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.

- 2. That the Council hereby concurs that the election results are valid and binding in accordance with the procedures so adopted by Resolution No. R-276511.
- 3. That the Redevelopment Agency of The City of San Diego is hereby directed to continue consulting with and obtaining the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area for a period of three (3) years after the adoption of the Centre City Redevelopment Plan, which was adopted May 11, 1992 by Ordinance No. O-17767.
