BE IT RESOLVED, by the Council of The City of San Diego that the proposal of C & M TRANSFER OF SAN DIEGO is hereby accepted and the City Manager is hereby authorized to execute a contract with C & M Transfer of San Diego as the primary contractor to provide OFFICE RELOCATION SERVICES FOR THE CITY'S OFFICE SPACE PROJECT as may be required for a period of thirteen and one-half (13½) months beginning November 15, 1992 through December 31, 1993, per prices on file in the Purchasing Department for a total estimated cost of \$200,000.00; terms net 30 days, with options to renew for three (3) additional one (1) year periods with price increases not to exceed 5% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED, that the proposal of COR-O-VAN MOVING & STORAGE is hereby accepted and the City Manager is hereby authorized to execute a contract with Cor-O-Van Moving & Storage as the first alternate contractor to provide OFFICE RELOCATION SERVICES FOR THE CITY'S OFFICE SPACE PROJECT as may be required for a period of thirteen and one-half (13½) months beginning November 15, 1992 through December 31, 1993, per prices on file in the Purchasing Department for a total estimated cost of \$20,000.00; terms net 30 days, with options to renew for three (3) additional one (1) year periods with no price increase.
