BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SEA WORLD SEWER EXPANSION INFLUENT SEWER REPLACEMENT FOR PUMP STATION NO. 43.

BE IT FURTHER RESOLVED, that the expenditure of \$401,368.00 from Sewer Revenue Fund 41506, CIP 44-001.0, ANNUAL ALLOCATION - SEWER MAIN REPLACEMENTS, is hereby authorized solely and exclusively for providing funds for said project and related costs.
