BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for BALBOA PARK CLUB BUILDING REHABILITATION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$56,000.00 from CIP No 58-007.0, ANNUAL ALLOCATION-OVERHEAD/OTHER CITY COSTS FOR GRANT PROJECTS, Capital Outlay Fund No. 30245, to CIP No. 21-826.0, BALBOA PARK CLUB REQUIREMENTS; and authorizing the expenditure of \$1,272,500.00 from CIP No. 21-826.0, BALBOA PARK CLUB REQUIREMENTS, \$1,216,500.00 from Balboa Park Grant, Fund No. 39042, and \$56,000.00 from Capital Outlay Fund No. 30245, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
