BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a third amendment to the agreement of January 12, 1987 with Boyle Engineering Corporation, for services in connection with the Morena Boulevard Interceptor, under the terms and conditions set forth in Amendment No. 3 on file in the office of the City Clerk as Document No. RR- 281001, together with any further amendments or modifications thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$82,732 from Sewer Revenue Fund 41506, CIP No. 43-123.0, Morena Boulevard Interceptor, is hereby authorized, solely and to provide funds for this amendment.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
