RESOLUTION NUMBER R- 081001

ADOPTED ON NOV 07 1992

WHEREAS, San Diego has the potential to generate hundreds of new high technology jobs, generate substantial property tax and sales tax benefits along with strengthening our international reputation as a high technology science and industrial center; and

WHEREAS, Governor Pete Wilson recently signed into law Assembly Bill 3096 which requires CalTrans to create a California Transportation Research and Innovation Center, a public-private transportation research center to develop alternative transportation technologies which enhance highway operations, "smart" vehicle systems, and apply existing high technologies to transportation systems; and

WHEREAS, the California Transportation Research and Innovation Center will be awarded through a highly competitive statewide bid process CalTrans will be developing; and

WHEREAS, we must act now to take advantage of this opportunity; and

WHEREAS, this proposal will result in the creation of environmentally clean technologies that will improve our air quality and further enhance our reputation as a leader in high-tech, aerospace and scientific research, allowing us to provide jobs locally and enhance our reputation for having a highly skilled workforce; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the City Manager be and he is hereby directed to work with
the steering committee to:

1. Provide regulatory, legislative and technical expertise
as needed, in order to select San Diego as the location of the
Center; and

2. Prepare an economic impact statement detailing the
potential benefits of this proposal; and

3. Develop a list of possible sites in the region for this
facility; and

4. Utilize the necessary City resources towards this goal;
and

5. Report back to the City Council in 60 days with a
status report on this effort.
