BE IT RESOLVED, by the Council of The City of San Diego, that Kim Construction is hereby declared in default of its contract for THE CONSTRUCTION OF SEWER GROUP 97, pursuant to section 6-4 of the Standard Specifications for Public Works Construction, as incorporated in said contract.

BE IT FURTHER RESOLVED, that the Engineering and Development Department, Field Division, is hereby authorized to negotiate with the Contractor's surety to immediately complete the project; and the City Attorney is hereby authorized to pursue recovering all costs to the City resulting from this action.

BE IT FURTHER RESOLVED, that Kim Construction and its officers and principals are hereby declared non-responsible bidders and therefore ineligible to submit bids to the City of San Diego for a period of three years.
