RESOLUTION NUMBER R- 281007

ADOPTED ON NOV 09 1992

WHEREAS, the contributions that Native Americans have made to our nation's history and culture are as numerous and varied as the tribes themselves; and

WHEREAS, each tribe formed a thriving community with their own customs, traditions, and system of social order; and

WHEREAS, half a millennium ago, when European explorers amazed their compatriots with stories of a New World, what they actually described was a land that had long been home to America's native people; and

WHEREAS, we honor this country's native people as vital participants in the history of the United States as well as valued members of San Diego's rich cultural tapestry; and

WHEREAS, 1992 has been declared by Congress to be the Year of the American Indian, recognizing the special place that Native Americans hold in our society, affirming the right of Indian tribes to exist as sovereign entities, and promoting greater mutual understanding and trust; and

WHEREAS, the Mayor's American Indian Advisory Board has worked tirelessly to educate the community about the contributions of American Indians and promote greater cultural understanding of the Indian people; and

WHEREAS, an educational exhibit about American Indians will be on display in the lobby of the City Administration Building November 2 through 20, 1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that November 1992 be and is hereby declared to be American
Indian Awareness Month in San Diego.

BE IT FURTHER RESOLVED, that the City Council encourages San
Diegans to visit the informational display in the Lobby of City
Hall to learn more about America's first people.
