
BE IT RESOLVED, by the Council of The City of San Diego that the low base bid of INSITUFORM SOUTHWEST, meeting the specifications, for CONSTRUCTION OF CRESCENT DRIVE DRAIN in the City of San Diego, California, in the amount of \$59,503.00, is hereby accepted, and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119654.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer \$17,000.00 FROM CIP 11-247.0, RECONSTRUCTION OF RIVIERA DRIVE STORM DRAINS, Proposition 'A' Fund 30300, to CIP 11-252.0, CRESCENT DRIVE DRAIN; and authorizing the transfer of \$9,500.00 from CIP 17-001, ANNUAL ALLOCATION - MINOR DRAIN REQUIREMENTS, Proposition 'A' Fund 30300, to CIP 11-252.0, CRESCENT DRIVE DRAIN.

BE IT FURTHER RESOLVED, that the additional expenditure of \$26,500.00 from CIP 11-252.0, CRESCENT DRIVE DRAIN, Proposition 'A' Fund 30300, to supplement funds previously authorized by Resolution No. R-280405 for a total of \$109,000.00, is hereby authorized solely and exclusively for said project and related costs.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
