WHEREAS, Section 98.0508 of Ordinance No. O-17454 (New Series) requires preparation of a Three Year Program Plan, to be submitted annually for City Council approval; and


WHEREAS, pursuant to the provisions of the San Diego Housing Trust Fund Ordinance the Housing Trust Fund Board of Trustees developed a draft revision to the Three Year Program Plan adopted by the City Council on March 26, 1991; and

WHEREAS, the San Diego Housing Commission considered and approved the draft Revised Program Plan developed by the Board of Trustees and submitted the draft Revised Program Plan to the City Council with a recommendation for approval; and

WHEREAS, the City Council has considered the draft Revised Program Plan approved by the Housing Commission and determined that the Program Plan appropriately addresses housing needs of low income residents of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the San Diego Housing Trust Fund Revised Three Year Program Plan - FY 1992 Through FY 1994 - Second Year Implementation Strategy is approved.
