VACATION OF RIBBONTREE COURT AND A STREET RESERVATION WITHIN SORRENTO HILLS CORPORATE CENTER, MAP 12607.

WHEREAS, it is proposed that Ribbontree Court and a street reservation within Sorrento Hills Corporate Center, Map 12607, be vacated; and

WHEREAS, there is no present or prospective use for the street, either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway or open space purposes; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, it is necessary and desirable that the vacation be conditioned upon completion of a consolidation parcel map for the affected parcels; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That Ribbontree Court and a street reservation within Sorrento Hills Corporate Center, Map 12607, as more particularly referred to in Resolution of Intention No. R- $\frac{280869}{}$ , adopted by Council on  $\frac{667171992}{}$ , is not necessary for present or prospective public street purposes.
- 2. That Ribbontree Court and a street reservation within Sorrento Hills Corporate Center, Map 12607, as more particularly shown on Drawing No. 17945-B, on file in the office of the City Clerk as Document No. RR- $\frac{280869}{}$ , which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.
- 3. That the vacation be conditioned upon the completion of a consolidation parcel map or other appropriate map in order to prevent the landlocking of parcels. In the event no such map is filed within three (3) years following the adoption of this Resolution, this Resolution shall become void and be of no further force or effect.
- 4. That the City Engineer shall advise the City Clerk of the completion of the required consolidation map, and that the City Clerk shall then cause a certified copy of this Resolution, with drawing, attested by him under seal, with drawings, to be recorded in the Office of the County Recorder.


