

RESOLUTION NUMBER R-8103

ADOPTED ON NOV 10 1992


BE IT RESOLVED, by the Council of The City of San Diego, that the management audit report of the San Diego Housing Commission from the consultant, Zucker Systems, is hereby accepted and referred to the City Manager for review.

BE IT FURTHER RESOLVED, that the Housing Commission and Housing Authority be placed under the direct management of the City Manager and that the Municipal Code be modified by delegating the role of the Executive Director to the City Manager or his designee.

BE IT FURTHER RESOLVED, that the Housing Commission be retained as a separate, corporate entity rather than being merged in as a City department.

BE IT FURTHER RESOLVED, that the Zucker Systems report be referred to the City Manager with respect to all other items except those related to the composition of the Housing Commission Board, and direct the City Manager to review, analyze and make recommendations for implementation to the City Council, Housing Authority and/or Housing Commission as appropriate for implementation, and that the City Manager commence implementation of operational items deemed feasible and within existing policy and authority.
