WHEREAS, on December 11, 1990, the City Council adopted the "City of San Diego's Urban Water Management Plan and Conservation Program" which includes an Ultra-low Flush Toilet Rebate Program ("Rebate Program") as one of eight (8) integrated and complementary water conservation programs; and

WHEREAS, the Rebate Program promotes the voluntary installation of ultra-low flush toilets, which use 1.6 gallons of water or less per flush, by providing cash rebates; and

WHEREAS, on May 6, 1991, the City entered into a Memorandum of Understanding ("MOU") with the County Water Authority ("CWA") to participate in the CWA's Ultra-Low Flush Toilet Program; and

WHEREAS, the City wishes to exercise an option to renew this MOU for an additional contract period; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager be and is hereby authorized to continue the Rebate Program in conjunction with the CWA.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby instructed to request the CWA provide the City with an additional one hundred ninety thousand dollars (\$190,000) in funds for the Rebate Program in order for the City to provide a one hundred dollar (\$100) rebate for each ultra-low flush toilet installed by a City water customer.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to exercise the option to renew the MOU with the CWA for services to implement and administer the Rebate Program for a second contract period of September 1, 1992, through June 30, 1993.
