BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$15,000 from CIP 62-272.0 to supplement Resolution No. R-278541 for a total of \$232,000, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
