RESOLUTION NUMBER R- 281067

ADOPTED ON NOV 16 1992

WHEREAS, the City of San Diego and the San Diego Inaugural Committee have established a community task force to plan the inauguration of Mayor-elect Susan Golding; and

WHEREAS, the task force has selected the evening of December 7, 1992, to conduct the swearing in of the new mayor and to hold the related inaugural events; and

WHEREAS, to pay for the expense of the inaugural program, funds need to be raised, a budget needs to be approved and the City Manager may need to execute contracts for and on behalf of the City of San Diego, provide that limitations on expenditures be restricted to the amount of money received as donations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the provisions of Council Policy 100-2 are hereby waived to allow receipt of donations for the Mayoral Inaugural Program on December 7, 1992.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to establish a special fund to record all revenues and expenditures of the inaugural program and thereafter deposit any excess donations in the General Fund.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute all contracts necessary regarding the celebration, said contracts to be funded to the extent of monies donated and received by the Auditor and Comptroller.

BE IT FURTHER RESOLVED, that the City Council hereby
approves the proposed task force budget for the inaugural program
on December 7, 1992.
