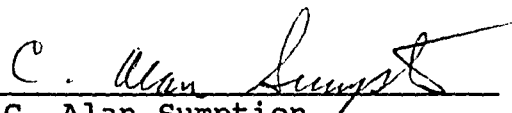
RESOLUTION NUMBER R- 281093
