BE IT RESOLVED, by the Council of The City of San Diego that the low bid of WARLOP LANDSCAPE is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF THE DESIGNATED MEDIANS, RIGHT-OF-WAY, AND LANDSCAPED SLOPES WITHIN CARMEL MOUNTAIN RANCH LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT as may be required for a period of one (1) year beginning November 1, 1992 through October 31, 1993, per prices on file in the Purchasing Department, for a total estimated annual cost of \$103,116.35; with terms of 2% 20 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 10%.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to the specifications.


