BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ARIZONA STREET LANDFILL GROUNDWATER MONITORING WELLS.

BE IT FURTHER RESOLVED, that the expenditure from Waste Management Enterprise Fund 30244 (Source Fund 41201), CIP 37-250 not to exceed \$159,000, is hereby authorized solely and exclusively for providing funds for said project and related
