WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Shawline Court, west of Shawline Street, in connection with a consolidation parcel map (TPM 92-0374), as more particularly shown on Exhibit "B," on file in the office of the City Clerk as Document No. RR-______, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That the resolution shall not become effective unless and until all existing public utilities and franchise facilities within the right-of-way to be vacated, have either been provided with service easements, removed, or relocated in a manner satisfactory to both the City Engineer and the affected utility companies. In the event that the above condition is not completed within one (1) year following the adoption of this resolution, then this resolution shall become void and of no further force or effect.
- 3. That the resolution shall not become effective unless and until the engineering permits for the required public improvements, which include construction of curb, gutter, and sidewalk across the vacated area, have been issued. In the event that the permits are not issued within one (1) year following the adoption of this resolution, then this resolution shall become void and be of no further force or effect.


