BE IT RESOLVED, by the Council of The City of San Diego, that the boundary of the Crosby Street (Harbor Drive to Kearny Avenue) Underground Utility District as established by Resolution No. R-279610 of March 24, 1992 be and it is hereby revised in accordance with the legal description affixed hereto as Exhibit A.

BE IT FURTHER RESOLVED, that the undergrounding of the 69 KV overhead utility lines contained within the revised district be and is hereby authorized. This authorization is an acknowledgement that this undergrounding is an exception to the general policy and procedure of the City as described in Resolution No. R-261978.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$54,000 from Annual Allocation - Undergrounding of City Utilities, CIP 37-028.0, Capital Outlay Fund 30245 and an amount not to exceed \$11,000 from Annual Allocation - Undergrounding of City Utilities, CIP 37-028.0, Capital Outlay/Other, Fund 302453, is hereby authorized, for the purpose of

Said district shall also include the following public rights-of-way:



northwest of the northwesterly line of Crosby Street and a line parallel to and 50' southeast of the southeasterly line of Crosby Street; LOGAN AVENUE between a line parallel to and 175' northwest of the northwesterly line of Crosby Street and a line parallel to and 300' southeast of the southeasterly line of Crosby Street; KEARNY AVENUE between a line 50' northwest of the northwesterly line of Crosby Street and a line parallel to and 50' southeast of the southeasterly line of Crosby Street; ALLEY BLOCK 94 between a line parallel to and 25' northwest of the northwesterly line of Crosby Street; ALLEY BLOCK 130 between a line parallel to and 50' northwest of the northwesterly line of Crosby Street; ALLEY BLOCK 140 between a line parallel to and 50' northwest of the northwesterly line of Crosby Street; ALLEY BLOCK 95 between a line parallel to and 25' southeast of the southeasterly line of Crosby Street; ALLEY BLOCK 129 between a line parallel to and 25' southeast of the southeasterly line of Crosby Street; ALLEY BLOCK 141 between a line parallel to and 50' southeast of the southeasterly line of Crosby Street; HARBOR DRIVE north of centerline between the southeasterly line of Crosby Street and a line parallel to and 300' southeast of the southeasterly line of Crosby Street.
