BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with San Diego Neighborhood Housing Services, Inc., a private, nonprofit corporation, for the procurement of affordable housing to benefit low income owner/occupants, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-281116.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from Fund 18528 (18th Year CDBG Entitlement), Dept. 4026, Org. 2603, is hereby authorized, solely and exclusively to fund the Rehabilitation Loan Program.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,000 from Fund 18528, Dept. 4026, Org. 2602, is hereby authorized, solely and exclusively for the purpose of providing funds to pay staff salaries.
