



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a fourteenth amendment to the agreement with SAN DIEGO FOUNDATION FOR MEDICAL CARE, to provide preferred provider services for CITYMED HEALTH PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 281131, to extend the agreement for a one-year period beginning August 1, 1992 through July 31, 1993, and to authorize a premium rate increase from \$1.75 per member per month to \$1.87 per member per month.
