WHEREAS, NADEP is an equal opportunity employer with a commitment to minority and disabled employment as evidenced by a 41.3% minority employment with an overall female employment of 17.5%; and

WHEREAS, NADEP has consistently proven its commitment to best value to the taxpayer by competing for and winning workload competitions within the public and private sectors; and

WHEREAS, through their foreign military sales accounts, NADEP attracts foreign dignitaries to the local communities, leading to broadened horizons in international trade and investment; and

WHEREAS, forty-three school districts benefit from the federal funds distributed to local schools serving the children of employees of NADEP; and

WHEREAS, NADEP has a dedicated proactive environmental office and is in the forefront of environmental issues affecting the local area; and

WHEREAS, NADEP has an active car pooling program with an occupancy per vehicle rate greater than the state average; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends the Naval Aviation Depot North Island and its employees for their contributions to the City and surrounding communities.

state, and federal governments, as a vital member of the San Diego family and business community.
