BE IT RESOLVED, by the Council of The City of San Diego, that the sole bids of 1. BADGER METER, INC., 2. CARLON METER CO., INC., 3. MUELLER CO. MKTG. GRP. FOR HERSEY PRODUCTS DIV. OF GRINNELL CORP., 4. KENT METERS, INC., 5. SCHLUMBERGER INDUSTRIES, INC. and 6. SENSUS TECHNOLOGIES, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS REPLACEMENT WATER METER PARTS as may be required for a period of one (1) year beginning November 1, 1992 through October 31, 1993, per prices on file in the Purchasing Department as follows:

1. BADGER METER, INC. for Item 1, at 33% off list price, with terms of net 30 days.
2. CARLON METER CO., INC. for Item 2, at 10% off list price, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 5%
3. MUELLER CO. MKTG. GRP. FOR HERSEY PRODUCTS DIV. OF GRINNELL CORP. for Item 3, at list price, with terms of 2% 15th and 30th days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 10%.

4. KENT METERS, INC. for Item 4, at 15% off list price, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods with option year price increases not to exceed the prices in effect for the previous contract period by more than 2%.
5. SCHLUMBERGER INDUSTRIES, INC. for Item 5, at 15% off list price, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 10%.
6. SENSUS TECHNOLOGIES, INC. for Item 6, at 10% off list price, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 7%.
