BE IT RESOLVED, by the Council of The City of San Diego, that the low and low acceptable bids of 1. PERVO PAINT COMPANY DBA COLORAMA PAINT and 2. JOHN C. HENBERGER COMPANY, INC., are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of TRAFFIC PAINT as may be required for a period of one (1) year beginning October 1, 1992 through September 30, 1993, per prices on file in the Purchasing Department as follows:

1. PERVO PAINT COMPANY DBA COLORAMA PAINT for Schedules I and II for an estimated annual cost of \$160,197.31; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods with price increases not to exceed 10% of the prices in effect at the end of each prior period.
2. JOHN C. HENBERGER COMPANY INC. for Section III for an estimated annual cost of \$27,831.83; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods with price increases for option period 1 not to exceed 5% of the price in effect at the end of the initial period and the remaining option periods with price increases not to exceed 8% of the price in effect at the end of each prior period.
