BE IT RESOLVED, by the Council of The City of San Diego, that the low bid of AZTEC LANDSCAPING INC., is hereby accepted and the City Manager is hereby authorized to execute a contract for COMPLETE LANDSCAPE MAINTENANCE OF THIRTY-EIGHT (38) DESIGNATED MEDIANS, RIGHTS-OF-WAY AND LANDSCAPED SLOPES WITHIN THE GAS TAX LANDSCAPED MEDIANS MAINTENANCE PROGRAM as may be required for a period of one (1) year beginning November 1, 1992 through October 31, 1993, per prices on file in the Purchasing Department, for a total estimated annual cost of \$109,391.40; terms 15% 20 days, with options to renew contract for four (4) additional one (1) year periods, with increases not to exceed 15% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, that in the event Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
