APPROVING MAP OF WESTVIEW UNIT NO. 5.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by William Gregory Clarke, Licensed Land Surveyor, entitled "WESTVIEW UNIT NO. 5, being a subdivision of a portion of the northeast quarter, and a portion of the north half of the southeast quarter of Section 30, according to record of Survey 6671, filed in the Office of the County Recorder of San Diego County, April 11, 1966, in Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the Official Plat thereof; the drainage easements granted to the City of San Diego recorded December 28, 1979 as F/P No. 540646, August 10, 1990 as File No. 90-439280, (Parcel "L" and Parcel "Q") and May 21, 1992 as File No. 92-0311226, all of O.R. are not shown within this map because they have been abandoned pursuant to Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of


access in and to Black Mountain Road, adjacent and contiguous to Lots 45 and 46, all as shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon, or across all those portions of Lots 45 and 46, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; those certain abutters' rights of access, together with the building restricted easement, all as granted and shown on the map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
