BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of May 27, 1992, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 281189-1, granting to said City an easement for public street purposes in a portion of Lot 43 of North City West Neighborhood 4A Unit 2, Map No. 12146, as more particularly described in said deed, and as more particularly shown on Drawing No. 17772-B on file in the office of the City Clerk as Document No. RR- 281189-2, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named THURSTON PLACE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
