BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, utility agreements with the State of California Department of Transportation (CalTrans), for: (1) the relocation and adjustment of water main facilities within the State Route 54/Reo Drive Bonita Pipeline Relocation Highway Improvement Project; and (2) the relocation and adjustment of sewer main facilities within the State Route 54/ Tonawanda Drive Sewer Relocation Highway Improvement Project; under the terms and conditions set forth in Utility Agreements No. 29019 and No. 29020, on file in the office of the City Clerk as Documents No. RR- $\frac{281207-7}{2}$ and No. RR- $\frac{281207-2}{2}$, as well as any reasonably necessary modifications or amendments thereto which do not increase these projects' scope or cost and which the City Manager may deem necessary from time to time to carry out the purposes and intents of these projects and agreements.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$29,000 from Water Revenue Fund 41500, CIP No. 73-024.0, Annual Allocation - Freeway Relocation, is hereby authorized, solely and exclusively to provide funds for Utility Agreement No. 29019 (water mains); and an amount not to exceed \$35,000 from Sewer Revenue Fund 41506, CIP No. 44-001.0, Annual Allocation - Freeway Relocation, solely and exclusively to provide funds for Utility Agreement No. 29020 (sewer mains).

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City Forces all the work to make connections and perform operational checks in connection with these projects, since the work can be done by City Forces more economically than if let by contract; with the cost of said work not to exceed \$13,000.
