
RESOLUTION NUMBER R- 281210

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a three-year lease agreement with Li-Ling and Pi-Shia Yu, for a police community relations office at 7345 Linda Vista Road, under the terms and conditions set forth in the Single-Tenant Lease on file in the office of the City Clerk as Document No. RR-281210, together with any reasonably necessary modifications or amendments thereto which do not increase this lease's scope or cost and which the City Manager may deem necessary from time to time in order to carry out the purposes and intent of this lease agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$8,379.28 from the Police Department Budget, General Fund 100, is hereby authorized, solely and exclusively to provide funds for this lease for the period December 1, 1992 to June 30, 1993.
