BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Erick L. Ricci, Registered Civil Engineer, entitled "Del Mar Summit," being the westerly 400.00 feet of that portion of the east half of the northeast quarter of Section 17, Township 14 South, Range 3 West San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof; excepting that portion, if any, lying southerly of the center line of the existing oil, surface road, extending in an easterly and westerly direction across the east half of the northeast quarter of said Section 17 (being the easterly prolongation of county Road A-39), as said road existed on April 30, 1957," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Lighthouse Way and a portion of White Emerald Drive, and said street and portion of street are hereby declared to be a public street and portion of public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress or egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over, upon, or across portions of lots 4 and 8, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said subdivision map, and that said public street and portion of a public street are accepted on behalf of the public as heretofore stated; that those easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as well as the building restricted easement, all as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
