WHEREAS, the National Affordable Housing Act of 1990 requires each jurisdiction to submit a Comprehensive Housing Affordability Strategy (CHAS) to be eligible to receive certain federal funds; and

WHEREAS, the City Council adopted San Diego's five-year CHAS on December 9, 1991; and

WHEREAS, federal regulations require submitting a Performance Report for Federal Fiscal Year (FFY) 1992 and an Annual Plan for FFY 1993 prior to December 31, 1992; and


WHEREAS, the San Diego Housing Commission reviewed the Draft FFY 92 Performance Report and Draft FFY 93 Annual Plan and recommended that the Council authorize submitting these draft documents to the U.S. Department of Housing and Urban Development (HUD); NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego does hereby authorize the City Manager to submit the Draft FFY 1992 CHAS Performance Report and the Draft FFY 1993 CHAS Annual Plan to HUD prior to December 31, 1992, and to release the draft documents for the required 30-day public review period.

BE IT FURTHER RESOLVED, that the City Manager is directed to return to the City Council with a final document early in 1993

which incorporates, as appropriate, comments received through the public comment process.
