

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a ten (10) year lease agreement with BRAEMAR PARTNERSHIP, a general partnership, for the use of a docking pier in Mission Bay, at a minimum yearly rental of \$7,200 vs. ten (10) percent of all gross income, whichever is greater, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a five (5) year permit with BRAEMAR PARTNERSHIP, for daylight use of a portion of the beach adjacent to the Catamaran Hotel pier for food, beverage and beach equipment concession, at an annual rental of \$500 per year vs. ten (10) percent of all gross income, under the terms and conditions set forth in that permit on file in the office of the City Clerk as Document No. RR- 281244-2
