

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Bement-Dainwood-Sturgeon, to provide engineering consultant services for the widening of Harbor Drive, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 281250.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$80,000 from CIP 68-011.0 "Annual Allocation - Modernize Top 5-10 Prioritized Traffic Signals", Capital Outlay Sales Tax Fund 30245 to CIP 52-546 "Widening of Harbor Drive".

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$80,000 from Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
