WHEREAS, the City has received applications to amend the Otay Mesa Community Plan, the Stonecrest Specific Plan (Kearny Mesa Community Plan), and the Mira Mesa Community Plan to propose locations for three commercial retail centers, each consisting of approximately 50 acres; and


WHEREAS, Council Policy 600-35; Processing of Community Plan Amendments provides that either the Planning Commission or the City Council may initiate community plan amendments; and
