WHEREAS, the permit was set for a public hearing to be conducted by the Council of The City of San Diego; and

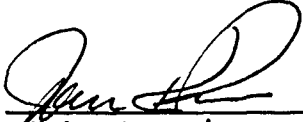
WHEREAS, the issue was heard by the Council on December 8, 1992; and

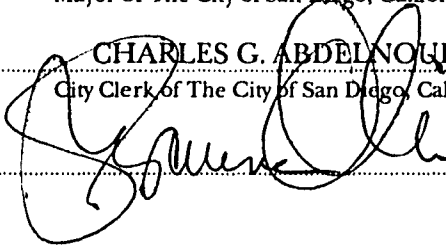
