RESOLUTION NUMBER R-281264

ADOPTED ON FEB 08 1992

WHEREAS, on February 11, 1992, the Council of The City of San Diego adopted Resolution No. R-277354, accepting the Water Reclamation and Reuse Conceptual Master Plan ("Conceptual Plan"); and

WHEREAS, the Conceptual Plan was prepared as a preliminary step in fulfilling Council Policy 400-12, "Implementation of Water Reclamation/Reuse," and Ordinance No. O-17327 (San Diego Municipal Code section 64.0801-0810), which relates to establishment of a Water Reclamation Master Plan and Implementing Procedures for The City of San Diego; and

WHEREAS, Ordinance No. O-17327 requires development of a facilities master plan for construction of reclaimed water production and distribution facilities; and

WHEREAS, the Conceptual Plan recommends preparation of a more detailed Reclaimed Water Distribution Master Plan particularly describing a facilities and distribution system for reclaimed water; and

WHEREAS, the Reclaimed Water Distribution Master Plan has been completed for Northern, Central and Southern Service Areas, and environmental impact review is presently being performed for the Northern and Central Service Areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council conceptually accepts the Reclaimed Water Distribution Master Plan for the Northern, Central and Southern

Service Areas, including the addendum evaluating the facilities required under the reduced-scale configuration termed the "Consumers' Alternative."

BE IT FURTHER RESOLVED, that future approval of any component of the Reclaimed Water Distribution Master Plan shall be subject to prior or contemporaneous approval of an Environmental Impact Report on the Master Plan.
